The submitted PEA confirms that the Site is not and does not form part of a priority habitat, nor is it in close proximity to one to cause impact. The majority of the site is laid to hardstanding with a small area of unkept grass to the frontage. This small landscaping strip would be retained, extended and improved as part of the development proposals. There are not any linear habitats such as hedgerows within the Site. Small areas of unkept grass that will be lost, totalling 24.4 m2. Therefore, given that the development impacts less than 25 m2 of on-site habitats and less than 5 metres of on-site linear habitats (zero in this instance), the development is exempt from the provision of the statutory BNG.
