Description

The proposal seeks planning permission for the change of use of the property from two self-contained residential flats (Use Class C3) to a single dwellinghouse (Use Class C3) as originally built.

The works comprise internal alterations only, including the removal of the internal division between the two flats and minor internal reconfiguration to form a single family home. No internal structural alterations are proposed, and there will be no changes to load-bearing walls, floors, roofs, or structural elements.

There will be no changes to the external appearance of the building, including the façade, roof, windows, doors, or access arrangements. No extensions are proposed.

The development will result in the reinstatement of the property as a single dwelling, improving the provision of family-sized accommodation in accordance with local planning policy and in keeping with the other properties in the street. The existing residential use will be retained, and there will be no intensification of use.

The existing arrangement results in two separate dwellings sharing a single driveway, which can lead to conflict where the parking of one occupier restricts access for the other. The proposal to revert the property to a single dwelling removes this conflict by creating a single planning unit with shared use of the driveway. This allows two vehicles to be parked off-street without obstructing access, improving the functionality of existing parking provision and reducing reliance on on-street parking.
