Three layout options were forwarded to the officer for comment and his preferred options both comprised a cranked unit to the east of the other house. He further suggested omitting the 2 storey outrigger to the front of this unit to increase separating distances to the neighbouring properties to the south.

The scheme has been revised in accordance with this advice with only a modest single storey bay in place of the 2 storey outrigger which has been moved to the rear of the property with a single window only facing east.
